


2. The Health Promotion and Disease Prevention and Public Awareness Campaign

3. The Designing of the Health Promotion and Disease Prevention Programme

Aims to create

1) a viable model used for collecting, receiving and sending of integrated health and service delivery data which could be effective in improving the administration of and access to health care services; and

2) a model suitable for monitoring and assessing health risk management plans

Insured person

1. Improve the communication channels covering all groups of people.
2. Increase the health checkup coverage for all types of workers and age.
3. Easy accessible from anywhere on any day.
4. Applicant self-service verification.
5. Provide the application that can investigate follow-up the health examination and medical outcomes as well as the treatment result system.
6. Provide the information to maintain health and prevent diseases
7. Provide the information on how to do health promotion and disease prevention.
8. Organize the activities on health promotion campaign and risk behavior.

Health care providers and other organization

1. Lifestyle change.
2. Provision of routine health checkup.
3. Exercise rooms for the employees.
4. Knowledge and awareness-building and education campaign.
5. Co-prevent the occupation diseases
6. Model hospitals for health promotion for the insured
7. Support the annual health examination program.
8. Promoting health expos.

Workplace

1. The workers are healthy workers.
2. Constantly health promotion behaviors.
3. Be able to visit the physician by an appointment and an after-hours clinic
4. Rewards to motivate healthy behaviors.
5. Procure the medical officers to acknowledge on health promotion in the workplace.
6. Accessible health record.
7. Integrated database and sharing of information.

4. The Creation of In-House Health Teams Initiative

To promote healthcare in the workplace by setting up healthcare teams in the enterprises (consisting of employers, HR, occupational health and safety officers, physicians, nurses and SSO's officers). Focusing on building basic skills and knowledge on health examination and risk factors assessment for non-communicable diseases (NCD), namely weight, blood pressure, waistline, uses of alcohol and tobacco. **(other than lab tests)**



Between March - June 2019, there were 445 public and private hospital applying for the health promotion and prevention (from 237 hospitals).

At present, there are 682 hospitals. Since the declaration of the Medical Committee, 697,218 insured persons received the services
